**A RESOLUTION OF THE SYRACUSE CITY COUNCIL APPOINTING A  
COMMUNITY AND ECONOMIC DEVELOPMENT DIRECTOR FOR  
SYRACUSE CITY.**

**WHEREAS**, Section 2.06.080 indicates the Community and Economic Development Director is responsible for administering the City's planning, zoning, and other land use ordinances; and

**WHEREAS**, the Syracuse City Council desires to employ a qualified individual to act in the position of Community and Economic Development Director; and

**WHEREAS**, Section 2.05.020 of the Syracuse City Municipal Code states that the Mayor, with the advice and consent of the City Council, may appoint and fill vacancies in all appointed offices provided for by law or ordinance; and

**WHEREAS**, Sherrie Christensen desires to work as the Community and Economic Development Director of Syracuse City; and

**WHEREAS**, the Administration, Mayor, and Council have found that Sherrie Christensen is qualified for the position based on her experience with the city and other jurisdictions;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF SYRACUSE CITY, STATE OF UTAH, AS FOLLOWS:**

**Section 1. Appointment.** The Syracuse City Mayor, with advice and consent of the Council, hereby appoints Sherrie Christensen to serve as the Community and Economic Development Director, pursuant to the City's Ordinances, Rules and Regulations.

**Section 2. Severability.** If any section, part or provision of this Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts and provisions of this Resolution shall be severable.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon its passage.

The purpose of the Work Session was for the Governing Body to hear public comments; receive an annual report from Justice Court Judge Bean; have pre-retreat budget discussions; discuss special meeting agenda item three – Animal Control Interlocal Agreement with Davis County; discuss RDA agenda items three and four – budget opening and the potential amendment of the contract with the Syracuse Family Fun Center; and discuss Council business.

Public comments

6:01:21 PM

TJ Jensen, stated he wanted to comment regarding the upcoming budget retreat and the discussion about metering water. He stated he has talked to a lot of residents about the current billing system and how it is unfair to residents with small families or a small number of people living at their house. He stated that the number one thing he hears is complaints about why people pay for others water when they are only using a couple thousand gallons of water each month. He stated restructuring the billing is something that some residents would like to see; that will put more of a burden on larger families, but it makes sense that the people using the water should be responsible for paying for it. He then stated that the Council has had a couple of discussions about electronic metering of water and he noted he thinks that would be in the City’s best interest in the long term, but trying to get the project finished in two years is a little ambitious. He stated that if the program were

1 spread out over five or 10 years, that would be easier for the Council to accept and budget for. He stated that anything that
2 will save the City money in the long term is a good idea.

4 Mayor Nagle noted a resident, Jayme Miya, sent an email to the Governing Body and that she asked that it be
5 included in the record as public comment. The email read as follows:

6 “I have sent e-mails to the current government of Syracuse. The only member of the government that has responded to me is
7 Mayor Nagle. She is the ONLY one who will get a re-election vote from me and my husband. I have sent several e-mails to
8 Councilwomen Lisonbee and Councilman Duncan. None have found the need to respond to me, a citizen of Syracuse, they
9 say they represent. What a complete joke. There is no one on the current City Council that represents me or my family. They
10 speak in council minutes about transparency and the fact they know better what the citizens of Syracuse need. Complete
11 verbatim minutes of council minutes. What a disgusting overuse of power, councilwoman Lisonbee. They in fact have made
12 the city of Syracuse a joke. I am disgusted that they think I am so stupid, I cannot figure this out. I have listened to the
13 council meetings on audio, and they are all about discrediting the mayor and city employees. At this point, there is no one in
14 the city council that my husband and I will support for re-election. The rest of the council seems scared to stand up to these
15 bullies, Lisonbee, Duncan and Shingleton. Since councilwoman Lisonbee and Councilman Duncan have not answered my e-
16 mails, their constituents, my husband and I, whose family owns World Wide Packaging and Crating of Utah will be attending
17 the next council meeting and the council members will answer us to our face. Our family business is dealing with the
18 Ninigret project and are in complete favor of it. It has the potential of increasing our business. The last thing this city needs is
19 more retail development in that area, to sit empty just like the entire city of Syracuse. What is this council doing to remedy

21 are educated enough that you will have to have more proof that what you are doing for the city of Syracuse is actually doing
22 this city anything positive and will increase business for this city and not just try to discredit the mayor for what she is doing
23 for this city. I would truly ask the government of this city to address my issues, if not we will have a face to face. And at this
24 time I demand answers to my questions. You are not able to hide behind whatever face you think you can hide behind. I can
25 also go to the newspapers and citizens with your complete incompetence to the citizens of this city.”

13 **Annual Report from Justice Court Judge Bean**

14 Justice Court Judge Bean is required to provide an annual report to the City Council. He used the aid of a
15 PowerPoint presentation to provide a brief presentation to the City Council. The PowerPoint presentation included the
16 following information:

- 17 • Syracuse City's justice court has been in existence for more than forty years (probably longer) (formerly known as
18 Justice of the Peace).
- 19 • Judge Bean has served as justice court judge since 1993 (19 years).
- 20 • Syracuse City Justice Court was a Class II justice court (avg. 201+ citations per month), may have dropped to a
21 Class III court (50 – 200 citations per month). Utah Code Ann. §78A-7-102(2).
- 22 • Court is certified by Judicial Council every four years. Utah Code Ann. §78A-7-103(1).
- 23 • Must meet certain minimum requirements for certification.
- 24 • Requirements depend on what "Class" the court is. (Number of support personnel).
- 25 • All justice courts "not of record" required to record its proceedings by 1 July 2012. Utah Code Ann. §78A-7-
26 103(3).

- 1 • Recording has not caused problems, thus far. Few requests for digital recording of a hearing (maybe only one or
- 2 two in nine months).
- 3 • Weighted caseload: .39 of full-time judge.
- 4 • Fewer citations (charges) filed in calendar year 2012.
- 5 • Weight of cases has been heavier. More jury trials.

6 Statistics 2012

- 7 • Number of traffic cases: 1765.
- 8 • Number of criminal cases: 285.
- 9 • Average cases per month: 170.83.
- 10 • Total revenue collected: \$493,160.84
- 11 • Revenue to Syracuse City: \$318,948.56
- 12 • Revenue to State of Utah: \$174,212.28

13 Recent Challenges

- 14 • Ethics Opinion 12-02 – prevents courts from referring defendants to specific counseling or probation providers.
- 15 • Usually have 3 – 4 representatives from counseling providers in court every Wednesday.
- 16 • DUI, Anger Management (DVA), Drug Counseling, Drug Testing, Theft Counseling (Cognitive Reconstruction).

17 Advantages of Local Court

- 18 • Local justice.
 - 19 – Community problem solved within the community.
 - 20 – Remains a problem solving court, not a revenue generating entity.
- 21 • Community sense of security.
 - 22 – Community wants to see “the little stuff” enforced. Gives a greater sense of security that the felonies are
 - 23 being enforced as well.

24 Justice Court staff and support:

- 25 • Will Carlson
 - 26 – Tough (four DVA jury trials in very short time)
 - 27 – Kind (Willing to compromise)

- 1 – Intelligent (quick, good judgment)
- 2 • Jody Howell / Debbie Rainford
- 3 – Very dedicated
- 4 – Willing to be flexible and adjust with the new policies, programs and procedures from the AOC.
- 5 • Police Department – very professional, good judgment, well prepared for court.

12 Attorney Carlson reminded the Council that court sessions are open to the public and the Council is encouraged to attend a
13 session to become familiar with the Justice Court process in Syracuse City.

16 **Pre-retreat budget discussions**

17 Copies of the various proposed budgets for the City have been provided to the City Council. This item was added to
18 the agenda to give the Council an opportunity to ask any questions about any items included in the proposed budgets.

20 Councilmember Johnson stated he has reviewed the budget and feels it looks good and is balanced.

22 Councilmember Shingleton asked what impact furloughs at Hill Air Force Base (HAFB) could potentially have on
23 the City. Finance Director Marshall stated the only direct impact furloughs would have on the City would be in the arena of
24 sales tax; if Syracuse City is home to many people that work on HAFB and they are furloughed, their spending habits could
25 be impacted. He stated it is too early to know the actual impacts. He noted he has budgeted flat for sales tax; he is projecting
26 \$2.9 million in sales tax revenue this year and for this same period last year the revenues are actually \$26,000 higher. He

1 stated the trend of raising sales tax revenues is still continuing and revenues are approximately five percent higher than last
2 year. He stated next year's proposed budget includes a sales tax revenue projection of \$2.95 million. He added one good
3 thing is that each year in July the City's population is reassessed and the City's population continues to increase each year
4 and continued increases will help to boost sales tax revenues.

6 Mayor Nagle noted that as the economy constricts there is the potential for an increase in domestic violence cases
7 and she asked Police Chief Atkin if that is the case. Chief Atkin stated it would be difficult to give a definitive answer
8 regarding domestic violence cases increasing, but in general there have been reports of increased domestic violence and theft
9 cases.

20 A memo from the Police Chief explained he wanted to provide the Council with information as they review the new
21 contract from Davis County Animal Control. After receiving the contract and list of incidents from Animal Control, City
22 Planner Noah Steele and Chief Atkin worked to verify that all the reported incidents actually occurred in Syracuse. A list of
23 questionable addresses was submitted to Animal Control for review; they were very good to work with and reviewed our list
24 for accuracy. As a result, Syracuse City saved \$449.68 for 14 calls that were invoiced but did not actually occur in the
25 boundaries of the City.

9 **Discussion regarding RDA agenda items**
10 **three and four – budget opening and amending**
11 **the contract with Syracuse Family Fun Center**

12 A staff memo from Finance Director Marshall explained Ed Gertge approached the City Council at the March 12,
13 2013 meeting and requested that the Council look at options to further assist with the Syracuse Family Fun Center expansion.
14 He requested additional funds to be front loaded from the RDA or the ability to postpone payment of building fees to a future
15 date in order for him to meet all of the upfront costs of the project. Staff was directed by the Council to bring options to this
16 meeting to discuss. We had discussed at the last meeting two different options. The first option was to draft a resolution that
17 would allow Ed Gertge to postpone payment of building fees to a future date. Currently our ordinance does not allow for
18 postponement of fees. The second option would be to increase the initial payment from the RDA to help pay the upfront
19 costs of the project. Mr. Marshall's memo expressed his opinion is that of the two options available, the best option for the
20 City would be to frontload the RDA payment. To be clear, this option is definitely feasible; however, as a Finance Director,
21 this is not his recommendation. The memo explained Mr. Marshall has prepared **two** PDF files attached with this summation
22 (included in the RDA meeting packet). One shows the current budgets with a \$300,000 payment in FY2013, while the other
23 shows a budget with a \$400,000 payment in FY2013. Highlighted in yellow are all the payments that would be affected by
24 frontloading more money now. Mr. Marshall's memo explained he briefly discussed at the last Council meeting that the City
25 Council, acting as the RDA Board, would need to decide if they wanted to front load additional funds to help pay for the Fun
26 Center expansion. The tradeoff is that there will be less money available in the next few years to spend on other potential

1 projects in the RDA. In the event that the City Council makes the decision to frontload additional funds to help with the Fun
2 Center expansion, we have set a public hearing for tonight with the option to adjust the RDA budget for FY2013.

3 A second staff memo from Finance Director Marshall explained staff is recommending making a few changes to the
4 contract agreement between Syracuse City and Syracuse Family Fun Center. The project has been postponed due to issues
5 with securing the financing to fund the expansion. As such, the contract needs to be modified to change the expected
6 completion date to November 30, 2013 and the payment of fees date to no later than July 1, 2013. These changes will ensure
7 that the construction can be completed in a reasonable amount of time. If the city council makes the decision to front load
8 more money from the RDA, the contract will need to be amended to consider the increase in the amount of funding approved.
9 Currently the amount for FY2013 is \$300,000.

1. Meeting Called to Order/Adopt Agenda

Mayor Nagle called the meeting to order at 7:05 p.m. as a special meeting, with notice of time, place, and agenda provided 24 hours in advance to the newspaper and each Councilmember. She asked all visitors present if any wished to provide an invocation or thought; Councilmember Duncan provided an invocation. Councilmember Peterson led all present in the Pledge of Allegiance.

2. Approval of Minutes.

The minutes of the Regular Meeting of July 10, 2012 were reviewed.

COUNCILMEMBER LISONBEE MADE A MOTION TO APPROVE THE MINUTES OF THE REGULAR MEETING OF AUGUST 28, 2012. COUNCILMEMBER DUNCAN SECONDED THE MOTION; ALL VOTED IN FAVOR.

3. Public Comments

1 Robert Gardner stated his comments are regarding the potential expansion of the Family Fun Center. He stated he
2 attended a meeting last week and it ended up being a Planning Commission meeting. He stated there are five homes
3 bordering the property line with the Family Fun Center and 80 percent of those property owners were in attendance to
4 address the Board and it was like they were talking to a brick wall. He stated there has been much time and effort spent on
5 this, but the first time residents were allowed to say anything about the project was last week, but it seemed like the project
6 was already a done deal. He stated that the residents have concerns about noise and pollution issues that have not been
7 addressed. He asked when it will be time for the residents' voices to be heard. He stated that he asked the Commission about
8 requiring that the doors to the building remain closed to keep the sound in. He stated that one argument that has been posed
9 to the residents is that they knew they were building next to a commercial zone. He stated he has heard similar concerns
10 from residents that live near the Syracuse Theater and the homes in that area are 500 or 600 feet away from the Theater. He
11 stated his home is 25 feet away from the Fun Center and he wondered who will protect him. He stated that maybe the
12 \$300,000 that is being donated by the City should be used to put up a sound wall. He stated he is also concerned about the
13 tall lights that will shine into the houses of the residents bordering the Fun Center. Mayor Nagle stated Mr. Gardner's time
14 has expired, but she asked him to stay after the meeting to talk to her about his concerns.

15 Laura Streeter stated that she also has concerns about the Fun Center; she has concerns about the excess noise and
16 the exhaust that will be generated by the go carts. She referenced some studies regarding asthma associated with increases in
17 pollution. She stated that the residents living near the Fun Center need to be heard because there are too many negative
18 impacts that will be put on the nearby residents while nothing positive will come from the project.

19 Terry Palmer stated that he wanted to make some comments regarding Robinson Waste. He stated that he is a
20 business owner and he understands how someone can make a mistake by placing a decimal point in the wrong spot. He
21 stated that he has always run his life based on what was meant to be and he never liked to cheat anyone out of anything just to
22 increase his ability to make a profit. He stated that he does not know Mr. Robinson and he did not plan on speaking about
23 this issue, but he feels that it is inappropriate for the City to agree to extend the contract for only one year after Mr. Robinson
24 has been willing up his guaranteed contract. He stated that he feels the City should extend the contract for a period of three
25 years. He stated that Mr. Robinson has been "raked over the coals" too much by the Council and his feelings are that Mr.
26 Robinson should be treated honestly and fairly and he would like to believe the rest of Syracuse is the same way.

1 TJ Jensen stated that Councilmember Johnson reported during the work session and the Antelope Island Stampede
2 will be held this weekend. He stated that he attended the County Commission meeting this morning and there was much
3 discussion about the event. He highlighted some of the events that will be taking place at the festival. He then mentioned the
4 upcoming Davis County Gala and reported that the purpose of the event is to raise funding for the Unlimited Play Park to be
5 constructed in the City. He stated the event will be held September 6 and he thinks it is very nice that the County is throwing
6 its weight behind the project.

12 5. Authorize Administration to execute the contract with Robinson Waste Management.

13 A memo from the City Attorney explained Robinson Waste Management and the City entered into a Garbage
14 Collection Contract ("Contract") dated April 1, 2009. In the contract, Robinson had a unilateral right to renew the contract
15 and the City agreed to pay Robinson a fuel allowance per household per month of .33% of the price of the price of diesel over
16 \$3.00 per gallon ("Fuel Surcharge"). On June 26, 2012 Robinson offered the City a new contract with a term of three years.
17 The City Council counter-offered with a term of one year. Robinson has now provided a counter-offer with a term of two
18 years.

19 Based on services for waste collection outlined in Robinson's July 31 invoice, staff provided an estimate of the
20 annual expenses to the city under the current and proposed contract as well as the estimated costs of an alternative provider
21 (estimate included in Council packet).

22 Robinson's proposed rates for traditional collection are an improvement from the current rates. The fuel surcharge
23 will increase from 0.33% to 33% and from a per house rate to a per service rate, but it will not initiate until diesel prices
24 surpass \$3.50 per gallon. Collecting on one side of the street will save the City money, and the greatest monetary savings
25 would be achieved by selecting an alternative provider to implement this collection method.

1 COUNCILMEMBER JOHNSON MADE A MOTION TO AUTHORIZE ADMINISTRATION TO EXECUTE
2 THE CONTRACT WITH ROBINSON WASTE MANAGEMENT USING THE TRADITIONAL COLLECTION
3 METHOD. COUNCILMEMBER DUNCAN SECONDED THE MOTION.

The purpose of the Work Session was for the Governing Body to receive public comment, discuss a potential budget opening, discuss Community Development Areas (CDAs), review the proposed rewrite of Title Seven of the Syracuse City Code, and discuss Council business.

Public comment.

6:00:33 PM

1 Joe Levi stated that he has been following the rewrite of Title Seven and he has some concerns, especially regarding
2 some of the comments that have been made, so he wanted to provide a hypothetical situation for the Council to consider. He
3 stated that someday down the road the City wants to turn over some power to the Public Works Director to make the streets
4 safer by adding more light to sidewalks and roads and the City will let the Public Works Director, who the City has full faith
5 and trust in, tell citizens that they must have 100 watt light bulbs on their front porches and they must burn that light from
6 dusk until dawn because it makes the City safer when there are lit streets and sidewalks. He stated that eventually the Public
7 Works Director may decide to dictate that residents need to use compact fluorescents or LED lights. He reiterated “we” have
8 full faith in the Public Works Director and no one thinks that “we” should make the City less safe by not having porch lights
9 on, but dictating that by regulation or by rule is not appropriate and is something that is best left up to the legislative body.
10 He stated the City Council is the people who write the laws and make the rules; not because “we” do not have faith in the
11 Public Works Director. He stated it is ridiculous that “we” would turn over legislative power to an appointed person, even if
12 that person has the full faith and trust of the City. He stated that if that person comes to the City Council and recommends
13 that lights be required to be on all the time and that an ordinance should be passed requiring that and the City Council allows
14 public comment and then decides that they are going to do that because they value the input of the employee making the
15 recommendation, that can be done at this table in front of the Council and the public. He stated those decisions should not be
16 made by someone that is appointed rather than elected. He stated that it is a bad precedent to set. He stated that he knows
17 that the Council is not talking about Public Works and instead another department of the City is the subject of Title Seven,
18 but the subject is passing off legislative responsibilities to an appointed person and that is wrong. He stated that “we” still
19 have full faith and trust in the Fire Chief, but saying that the Fire Chief should be allowed to make rules and regulations that
20 are enforceable by punishment of law, that is not appropriate and should be done by the Council. He stated it is not the
21 Council’s job to pawn off those responsibilities by delegating them to other people. He stated doing so is a dereliction of the
22 Council’s duty because the citizens elected and hire them to write the laws of the City and he does not want someone that he
23 has not elected making rules or laws for him.

26 Ray Zaugg stated that regarding Title Seven he would like to talk about the agricultural aspect of that document;
27 there are laws on the books in Utah that talk about not requiring permits to burn along fence rows, etc. He stated the City

2 farmers are simply required to notify the Fire Department of their intent to burn on a specific day. He then stated the other

9 Discussion regarding potential budget opening

10 A staff memo from Finance Director Marshall explained he has closed the books for FY2012 and is currently
11 awaiting the financial auditor’s completion of the audit. The City’s unrestricted fund balance in the general fund at June 30,
12 2012 increased to \$1,454,387 or approximately 17.26% of budgeted revenues. State Code requires that our fund balance be
13 between 5-18%. Administration’s philosophy is to maintain a healthy fund balance between 10-14%. This allows the city to
14 maintain a healthy rainy day fund but also allows a portion of fund balance to be used in operations for our most critical
15 needs. Staff has also projected revenues in FY2013 that are going to exceed original budgeted amounts. Administration has
16 brainstormed and come up with several options for using these excess revenues and fund balance. Administration
17 recommends that the excess revenues and fund balance be used for suggested options within the power point slide.
18 Administration also recommends that we move forward with the additional capital improvements projects.

25 could be increased. He stated the crew is backfilled with part time staff and overtime rates are paid. Mr. Rice added that

12 receive a \$3.00 per hour increase in Bountiful, which equates to \$6,000 a year. He stated that two other officers are going to
13 Kaysville and they could potentially get a \$5.00 per hour pay increase, which equates to approximately \$10,000 per year.
14 Mayor Nagle stated that the City has made a significant investment in one of those officers. Chief Wallace agreed and stated
15 one is the K-9 officer. Councilmember Johnson asked what percentage increase \$10,000 translates to. Mr. Marshall stated it

3 in Syracuse is \$80,000, but two thirds of households have dual incomes, he wondered how that compares. He stated that
4 each person could be making \$40,000 a piece. Councilmember Peterson agreed and he noticed that comparison also, but the
5 thing that stood out to him the most in the presentation is the argument for the need to invest in employees. He stated the
6 employees need a raise because they have not had one for a long time and they deserve one. Councilmember Duncan stated
7 he has another concern. He stated that merit pay is hard to do in government; he is worried about the guys that are making
8 \$12.00 per hour because they are at the bottom and he wondered if they should be given more consideration than those
9 making considerably more money. Mayor Nagle stated that the raises will be discretionary based on performance.
10 Councilmember Johnson stated he would also think that the staff would look at the current salary of certain employees and
11 see if there is a way to get them more of an increase if they are underpaid. Councilmember Duncan asked how many cities
12 responded to the request for information regarding their salaries. He stated he would like to see how Syracuse compares to
13 other cities; it is hard to compare to a private sector. He stated he knows of certain government employees that are making
14 more money than those in the private sector. Mayor Nagle stated that it is not possible to benchmark a Police Officer's salary
15 with a salary in the private sector. Councilmember Duncan stated he knows that and that is why he would like to see the
16 information from other cities. City Recorder Brown stated that the staff did not conduct a true benchmark analysis; instead
17 they just asked what cities had provided raises to their employees over the past five years. She stated that if the Council
18 wants an actual benchmark it would be possible for staff to provide that by using a program the City subscribes to that
19 provides data for every City in the entire State. She stated, however, that staff has done that in the past year and it was
20 rejected. Councilmember Johnson stated he feels the information is more viable now that the City has the money available to

27 benchmark data is typically used to set the overall wage scale of the City. She stated that if the starting pay for a patrolman

1 in Kaysville is \$17.00 per hour and Syracuse City's is \$12.00 per hour, the Council needs to do a lot more than give raises –
2 they need to adjust the entire wage scale. She stated that is what the City did in 2007, which was the last time employees
3 received raises. She stated that same wage scale has never been adjusted again based on the true cost of living. She stated if
4 staff is being directed to conduct a survey they need to know exactly what the Council is asking for. Councilmember
5 Peterson stated he does not mind seeing that information, but it is pretty safe to say that the City's wages are low. He stated
6 that property taxes were raised in 2007 in order to adjust the City's wage scale according to benchmarking data, but no raises
7 have been given since then. He stated he would think it is safe to say that the City's wages are low. Mayor Nagle added she
8 also thinks it is safe to say that there has been a general consensus from the Council that the economy is still "in the toilet"
9 and it is the employees that have recognized these savings in the City's budget. She stated that even with the surplus the City
10 is dealing with, they have been able to put \$3.7 million into roads and infrastructure this year. She stated that three years ago
11 that same budget was \$78,000. She stated that at some point the Council needs to recognize that the City asked the
12 employees to tighten their belts and reconfigure the way they do business and they have done that and they are deserving of a
13 raise. She stated that just because someone works for government does not mean they should never receive a raise.

14 Councilmember Duncan stated he understands that, but he also recognizes that the average household income for the middle
15 class in the United States is shrinking right now, so it is not just a government issue; revenues are a problem and people are
16 struggling across the board. He stated that he struggles with this because there are several citizens who are not keeping pace;
17 they are losing money over the last five or six years. He stated the Council needs to find a balance; he is not saying he is
18 against wage increases, but his biggest concern is dealing with the people that are floundering at the bottom. He stated that
19 he worked for government in Atlanta and he was at the bottom when he started and one of the first things they did was put a
20 pay freeze on for two years; he was making less than \$40,000 a year and paying student loans and the pay freeze hurt him
21 more than it hurt his boss who was making over \$100,000 a year. He stated there are several things the Council needs to
22 consider and understand that the economy is affecting everyone, but also try to understand who it is affecting the most.

23 Mayor Nagle stated that she takes issue with that because at the last meeting Councilmember Duncan said that one of the
24 reasons he was opposed to the Ninigret project was because of the high demographics of the City and that our citizens did not
25 need those jobs. She stated that if he is saying the economy is so healthy that the City does not need to look at jobs, why is
26 the Council not considering raises for our associates that have provided the budget turnaround for the City.

1 Councilmember Lisonbee stated that she has a few concerns as well; she agrees that, while it would be nice to pay
2 everyone enough for them to be really comfortable and have yearly raises, the bottom line when she is out talking to citizens
3 is that most of them have not received a raise in as many years and they do not expect a raise in the near future. Mayor Nagle
4 disagreed. Councilmember Lisonbee stated that one of her concerns is that if the Council commits this amount of money this
5 year, that will translate to an ongoing commitment of more than \$150,000, which ultimately translates to \$2 million over the
6 next 10 years. She stated the Council does not know what will happen next year and what will be needed in infrastructure
7 upgrades and other costs. She stated it may be unwise for the Council to commit that kind of capital outlay for the next 10
8 years until they are sure what they are facing as far as infrastructure needs. She stated that in looking at wages the City is
9 fairly comparable when considering the increase in benefits that public employees get according to the study done by the
10 Utah Tax Association; public employees receive approximately five percent more in benefits than their private sector
11 counterparts. Mayor Nagle stated that the Department of Human Resource Management of the State is required by law to
12 conduct a benchmark salary survey every two years. She stated that this was headed by John Dougal who said he did not
13 have confidence that the State was giving accurate information and so at the Legislative Session two years ago the
14 Legislature funded Mercer to conduct an independent study. She stated that while they did say that the benefits were richer,
15 they also said the wages were lower and that survey must be considered in totality. She stated that is why the State
16 employees received a benefit and wage increase this year. She stated Councilmember Lisonbee's comments are absolutely
17 true when considering federal wages and that is what Mercer debunked with their study; the federal wages and benefits far
18 exceed state and municipality wages and that is where the difference is. She stated there is merit to what Councilmember
19 Lisonbee is saying, but that is considering federal benefits rather than benefits on the local level. Councilmember Lisonbee
20 stated that the study she was referring to was conducted by the Utah Taxpayers Association and it was referring directly to
21 communities; it was written by a certified public accountant (CPA) who was on the Council of one of the cities and he
22 figured that out. Mayor Nagle stated it is not a comprehensive survey. Councilmember Lisonbee stated she simply wanted to
23 express her concerns. Mayor Nagle stated that she finds it very problematic that the Council has asked the employees to do
24 so much and they get beat over the head constantly; they are not appreciated, they are told to do more, and that they do not
25 deserve the pay or the benefits they get. She stated they have sacrificed a lot and there will always be the need to invest in
26 employees and if that is not done, the employees will leave. She stated the City has seen good employees leave and there is
27 the potential for even more to leave. She stated the City invest in their training and then cannot retain them. She stated that

1 at some point the Council needs to stand up and say they are being very responsible with the taxpayers' dollars and
2 recognizing the employees for all they have done. She stated the Council is not bringing ideas for cost savings; rather those
3 ideas are being brought to the Council by the employees. She stated that at some point the Council needs to be willing to
4 invest in the employees. Ms. Brown stated that the Council continues to refer to people employed in the private sector that
5 have lost money over the last several years. She stated that the same is true for City employees. She stated that she started
6 working for the City in 2006 and she received an increase in 2007, but every year since then her wages have actually been
7 decreased due to increased benefits that have been passed on to the employees. She added that the 401K match that was
8 given to the employees was also eliminated. She stated that she is concerned that City employees are being compared to
9 employees in the private sector and comments are being made that the private sector employees have been impacted
10 negatively while the City employees have not. She stated that is not true. Councilmember Duncan stated that is not what he
11 is saying; he is simply saying that the Council needs to consider the reality. He stated he thinks everyone should make more
12 money. He stated that at his own employment the pay increases have been decreased at the expense of the partners. Mayor
13 Nagle asked if the wage increases have been reduced or eliminated. Councilmember Duncan stated some wage increases are
14 still given, but it is at the expense of his firm making any profits. Mayor Nagle stated that she works in the human resources
15 field and she is currently conducting a massive survey of private sector employees and she can tell the rest of the Council that
16 the increases have not stopped and they have actually picked up. She stated that over the last two years the vast majority of
17 employers are giving raises. Councilmember Duncan stated that he talks to a lot of citizens that say they have not received a
18 raise for a significant amount of time. He stated his concern is that the Council needs to consider the economy and find out
19 how to justify a three percent increase when there are citizens that have not received raises in several years. Mr. Rice stated
20 that he is missing Councilmember Duncan's point. He stated that revenues in the City have been increased by \$700,000 due
21 to the work of the employees; if the Council looks at the City as a business they must understand the employees have made
22 the business stronger. He stated that businesses that do very well invest in their employees. Councilmember Johnson agrees
23 with Mr. Rice. He stated that if one company is doing very well and is capable of giving raises to their employees, they
24 should not forego those raises just because another company may not be doing as well as them. He stated he thinks the
25 Council needs to be smart and look at investment along with the competitive nature of the City's wages. He added that he
26 also feels the money needs to be budgeted in the City's budget each year. He stated that will alleviate some of
27 Councilmember Lisonbee's concerns; if the revenue is ongoing each year the City will have the money to pay for the raises.

1 He stated that he does not have a problem with the request and he does not think the staff is actually asking for that much
2 money, especially when the employees have not received raises for some time.

4 Fire Chief Froerer stated that it is worth reiterating the Mayor's point about the cost of losing talent. He stated that it
5 will cost a large amount of money to replace the K-9 Officer and his dog. He stated that he has employees that are looking
6 for employment elsewhere as well and if he were to lose one of his Engine Bosses that would be a severe detriment to the
7 City's wildland program that produces \$200,000 in revenue for the City. He stated the same is true in any department of the
8 City. Councilmember Duncan stated that is why he wants the benchmark data; he wants to compare apples to apples. He
9 stated he does not want to simply give raises because the employees deserve it; there are a lot of people that deserve raises
10 and they are not getting them right now. He stated he wants the City to be competitive and that is the most important issue to
11 him. He stated he does not see the information to address the issue of competitiveness in the packet for this meeting. He
12 then stated he wanted to respond to the Mayor's comments about Ninigret. He stated that in looking at the median household
13 income for Syracuse residents, which is \$80,000, that is why he has said that Ninigret will not provide a whole lot of jobs for
14 the residents here because they do not work for those kinds of wages. Mayor Nagle stated the \$80,000 is made up of two
15 incomes. Councilmember Duncan stated that people will not be earning \$40,000 working for the types of companies that
16 will be located in the Ninigret development. Mr. Rice stated they will actually be making a little more. Mayor Nagle stated
17 that \$40,000 is less than \$20 per hour. Councilmember Duncan stated that he does not foresee Ninigret bringing a lot of jobs
18 to the City, but he does not know how it relates to this discussion.

20 Councilmember Peterson stated that he agrees with Councilmember Duncan in his request for benchmark data, but
21 not for the reasons of justifying the \$150,000 that the staff is asking for. He stated he thinks the work the employees have
22 done justifies the \$150,000. He stated he would like the benchmark data to be used in preparation of next year's budget and
23 he would like to look at the wage scale as a whole.

25 Mr. Marshall then continued to review his presentation, with input from Mr. Rice and Mayor Nagle.

1 Councilmember Lisonbee stated that if the Council is considering giving a three percent increase across the board
2 she would like to see a benchmark study done comparing the City to cities of like size and population. She stated she thinks
3 that the City's salaries are actually above the average in some areas while there may be some that are lower than average.
4 Mayor Nagle stated that the staff is not talking about giving a three percent increase across the board; rather the employees
5 will receive a raise based on their merit, though \$150,000 spread across the number of employees the City currently has
6 averages three percent. Councilmember Duncan stated that he would like to see the benchmark data that Councilmember
7 Lisonbee is asking for. Mayor Nagle concurred. Councilmember Lisonbee then stated she wanted to discuss some of the
8 other items in the budget opening presentation. She stated she would submit that it may be wiser to purchase used trucks for
9 the Fire Department because that will prevent the City from paying a premium for a new automobile.

11 Mayor Nagle stated that she is not in favor of bringing on new Police Officers right now; the City is in the process of
12 transitioning to a new Police Chief and she thinks it will be better to wait until a new Chief is on board and allow him to
13 assess the Department and bring the proposal to the Council if he feels it is necessary. Councilmembers Johnson and Duncan
14 agreed. Mayor Nagle stated that if the Police Officers are paid such low wages she would rather forego the hiring of
15 additional Police Officers and raise the wages of the existing officers to where they need to be in order for the City to be
16 competitive. Councilmember Duncan agreed and stated the reason he wants the benchmark data is because competitiveness is
17 a high priority to him. He asked if it would be appropriate to consider diving the \$150,000 in a manner that some could be
18 used for merit increases the rest could be used for COLA. Mayor Nagle stated that she thinks COLA's are a horribly bad
19 idea because they reward someone that is just barely showing up for work every day the same as the top performers.
20 Councilmember Johnson agreed. Councilmember Duncan stated that the idea is that looking at both options would be
21 important for the City; if the City gives a COLA the wage scale will be adjusted. Mayor Nagle stated that the wage scale can
22 be adjusted without a COLA increase.

24 Councilmember Peterson stated that regarding the issue of hiring new Police Officers, he has heard that there should
25 be one Police Officer per 1,000 residents in the City. He stated Syracuse has 19 Police Officers and a population of 25,000.
26 He stated he sees some merit in adding new Police Officers. Councilmember Johnson asked where that statistic comes from.
27 Mr. Rice stated that it is a generally recognized rule amongst the law enforcement community. Councilmember Duncan

1 stated the numbers are a good guidepost, but it would be better to look at reality when determining how many officers the
2 City needs. Mr. Rice stated that the City is always short on patrolmen because many officers are assigned to other tasks. He
3 stated he thinks the City needs more Police Officers but he agrees it would be appropriate for the new Police Chief to assess
4 the Department and bring a proposal to the Council as necessary. He then provided an explanation for the proposal to
5 transition to Police Officers using motorcycles.

7 Mayor Nagle then stated she wants to get a response to Councilmember Lisonbee's recommendation to purchase
8 used vehicles rather than new ones. Mr. Rice stated that the City has access to the State contract, which can be used to
9 purchase vehicles. Chief Froerer added that the City has access to significantly reduced prices for vehicles. He stated that he
10 also does not know that the City will find the type of vehicles the City needs when searching used vehicles.

13 holds. He provided a further explanation; that led to a discussion about how much money the Council would like to keep in

15 Councilmember Johnson stated that he does not want all of the money to go to paying down debt, but some of it could be
16 used for that purpose.

22 Discussion regarding Community Development Areas (CDAs)

23 A memo from City Attorney Carlson explained after the Syracuse Redevelopment Agency and Syracuse City
24 Council approved the Economic Development Project Area Plan for the area east of Syracuse High School, Councilmember
25 Lisonbee asked the City Attorney to research whether the city could unilaterally create a Community Development Project
26 Area Plan (CDA Plan) for at least part of that same area. This memorandum is the answer to that request. The City Attorney's

1 conclusions are 1- The City has the power, in concert with the Syracuse Redevelopment Agency, to create a CDA plan
2 without the participation of any other taxing entities, and 2- The current ambiguity regarding development in the area, the
3 lack of funding for unilateral plans, and the high likelihood of a need to amend the plan later lead the City Attorney to
4 recommend against proceeding with a CDA plan at this time. The Syracuse Redevelopment Agency was created under an
5 earlier version of State code which has since been replaced. While a CDA plan can include as much additional information as
6 the Agency deems necessary or advisable, there are eleven elements which the CDA plan must include:

- 7 1. A description of the boundaries of the project area;
- 8 2. A general statement of the land uses, layout of principal streets, population densities, and building intensities of the
9 project area and how they will be affected by the community development;
- 10 3. The standards that will guide the community development;
- 11 4. A demonstration of how the purposes of a CDA will be attained by the community development;
- 12 5. Indication of consistency with the general plan and show that the community development will conform to the
13 community's general plan;
- 14 6. A description of any specific project or projects that are the object of the proposed community development;
- 15 7. Identification of how private developers will be selected to undertake the community development and identification
16 of each private developer currently involved in the community development process;
- 17 8. The reasons for the selection of the project area;
- 18 9. A description of the physical, social, and economic conditions existing in the project area;
- 19 10. A description of any tax incentives offered private entities for facilities located in the project area; and
- 20 11. An analysis of the anticipated public benefit to be derived from the community development, including the
21 beneficial influences upon the tax base of the community and the associated business and economic activity likely to
22 be stimulated. UCA §17C-4-103

23 The process for approving a CDA plan is outlined by state code. Before taking any action, the Agency must adopt a
24 resolution that authorizes the preparation of a draft CDA plan. UCA §17C-4-101. At that point, the draft CDA plan is created
25 and the Agency conducts any examination, investigation, and negotiation that the agency considers appropriate. §17C-4-102.
26 The CDA plan must then be made available to the public. A public hearing must be held next, after which the Agency can
27 revise, reject, or approve the CDA plan. At that point, the CDA plan is presented to the City Council for adoption.

1 Plans are funded by an agency based on the project area budget. The agency usually obtains the funding for the
2 project area budget by collecting a tax increment. A "tax increment" is the difference between the amount of property tax
3 revenues generated each year in the project area and the amount of property tax revenues that would be generated from that
4 same area if the plan had not been implemented. The tax increment only comes from taxes paid in the identified project area.
5 Tax payers outside the project area do not subsidize the increment.

6 EDAs, URAs, and RDAs created prior to 2006 are funded by the tax increment as approved by a Taxing Entity
7 Committee ("TEC") A TEC consists of representatives of:

- 8 1. The School District;
- 9 2. The County;
- 10 3. The City;
- 11 4. The State Board of Education; and
- 12 5. Special Districts.

13 As representatives of government agencies that each collect a portion of property taxes, these members of the TEC
14 are empowered to commit their respective agencies to a specific amount or percentage of tax increment to dedicate to the
15 Project Area Plan's budget.

16 CDA plans are funded differently. Rather than form a committee to approve the tax increment, the Agency must
17 come to an agreement with each independent taxing entity regarding how much, if anything, the entity is willing to dedicate
18 to the CDA plan. This agreement can be memorialized through an interlocal agreement or a resolution. Utah Code §17C-4-
19 201(2). This allows an Agency to create a CDA plan regardless of the cooperation of other taxing entities, but it also
20 complicates funding of the plan.

21 According to the Davis County Economic Development Department, the first CDA Plan in Davis County was
22 implemented in 2010. After implementing the plan, Davis County anticipated that many more could follow and so they
23 created a guiding policy for county participation in CDAs. *See attached.* County participation is heavily weighted in favor of
24 job creation. According to Davis County's Marlin Eldred, "we want job creation centers. We are not wanting to incentivize
25 housing or retail. As you look at the [guiding policy] you will notice the level of participation goes down as there is more
26 housing and retail in a project area."

1 Mr. Eldred indicated that the Davis School District “views it from a different perspective but the same premise. The
2 school district views housing will equate to families that will bring kids that they have to provide an education for.... Retail
3 isn’t a huge drain on them but job creation centers are no drain on the school district.” As a rule, the school district has also
4 preferred shorter time frames for CDAs than the county.

5 Gauging the interest of the County and School District in any CDA plan is important because of the percentage of
6 property tax that goes to those entities. Most paid property taxes do not go to the city, so even if the city were to dedicate
7 100% of a tax increment to a CDA plan, the value of that increment without any other taxing entity would be minimal.

8 City Council interest in creating a CDA plan has focused on the area east of Syracuse High School. Some concern
9 was expressed by the Council that approving an EDA plan without also creating a CDA plan might give developers the
10 wrong impression about what kinds of development Syracuse is inclined to approve in that area. In spite of this concern, state
11 code is quite clear that neither an EDA plan nor a CDA plan constitute a land use ordinance for an area:

12 “An ordinance or resolution adopted under [The Community Development and Renewal Agencies
13 Act] is not a land use ordinance...” Utah Code §17C-1-104(2).

14 The current EDA plan only addresses and budgets for the area east of the power lines. Any amendments that address
15 development west of the power lines would have to be approved by both the Agency and every affected taxing entity. Utah
16 Code §17C-3-109(3). Concerns that the approved EDA plan dictates terms of development west of the power lines are
17 unfounded. Developers interested in the area must look to the General Plan and the city’s land use ordinances.

18 The land area between Syracuse High and the power lines have been addressed by the General Plan. Current city
19 planning, zoning, development, and subdivision ordinances also govern the area.

20 While the city could quickly create a description of the boundaries of the project area, the other state requirements
21 for a CDA plan require information that the city currently lacks. For example, the CDA plan must include a description of the
22 specific project or projects that are the object of the proposed community development, but right now there are no specific
23 projects being proposed, nor a clear object of the possible CDA plan, short of enforcing the General Plan. Without a clear
24 objective and specific projects in support of that objective, the city will have great difficulty identifying a necessary budget
25 and will be unlikely to convince other taxing entities to contribute tax increment to that budget.

26 As specific projects are proposed for a geographic area, the City will be in an ideal position to evaluate whether
27 those projects provide a public benefit sufficient to justify diverting property tax dollars from the area back into those

1 projects. If the answer is yes, a CDA is one tool that can be used to incentivize that development. In the absence of any
2 proposed projects, the General Plan and land use ordinances are more effective tools for communicating city expectations to
3 developers. If the city creates a plan now, it is highly likely that it will need to be amended when specific projects are
4 introduced. Such Amendments would require the city to restart the approval process. Utah Code §17C-4-108

5 Mr. Carlson's memo concluded by noting he was asked whether the City could unilaterally create a CDA Plan for
6 the area east of Syracuse High School. The City Attorney's conclusions are 1- The City has the power, in concert with the
7 Syracuse Redevelopment Agency, to create a CDA plan without the participation of any other taxing entities, but 2- The
8 current ambiguity regarding development in the area, the lack of funding for unilateral plans, and the high likelihood of a
9 need to amend the plan later lead the City Attorney to recommend against proceeding with a CDA plan at this time.

11 Mr. Carlson summarized his staff memo.

13 Councilmember Duncan asked if the requirements of a CDA are similar to those for an Economic Development
14 Area (EDA) plan. Mr. Carlson stated there are some overlapping requirements. He stated the EDA project budget plan is
15 similar. Councilmember Johnson stated he thinks the recommendation to wait is a good one; he would rather focus on the
16 General Plan for that area first. He stated he does not want to see industrial development in the area and so he does not want
17 to incentivize that kind of development, but he would be happy to incentivize office or commercial space. Councilmember
18 Duncan stated that EDA's cannot be used to incentivize commercial development. Councilmember Johnson agreed and
19 stated that the CDA could be overlaid with the EDA. Mr. Rice stated the problem is that there is such a small amount of
20 money to incentivize because the entity only gets 13 percent of the property tax; the pool of money is very small.

21 Councilmember Johnson stated that an EDA can be used to incentivize job growth through office space development in a
22 business park. He stated that is what he would recommend. Mayor Nagle stated that the City cannot direct the landowner to
23 do certain things with their property. Councilmember Johnson stated the Council can direct the staff to have conversations
24 with the landowners. He reiterated he does not want to incentivize industrial grown west of the power lines. Councilmember
25 Duncan stated that he wants a CDA in the area, but he does not think it is practical to do that. Mr. Carlson agreed that it is
26 not practical to do it right now. Councilmember Duncan stated that the City is currently at an impasse with Ninigret and
27 everyone's ideas need to be considered to determine how the land should be used. Mayor Nagle stated that it sounds like the

1 idea of a CDA should be put on hold until the property owner approaches the City to reopen that discussion. Mr. Carlson
2 stated that the zoning laws and general plan are land use ordinances and they tell the developer what they cannot do. He
