

COMMERCIAL OR INDUSTRIAL REQUIREMENTS
FOR SUBMITTING
CONSTRUCTION DRAWINGS
TENANT IMPROVEMENTS

WHEN SUBMITTING ANY COMMERCIAL OR INDUSTRIAL CONSTRUCTION DRAWINGS FOR PLAN REVIEW, THE FOLLOWING INFORMATION IS REQUIRED.

- 3 COMPLETE SETS OF RED STAMPED PLANS
- 1 PDF ELECTRONIC RED-STAMPED PLANS
- COMPLETED BUILDING PERMIT APPLICATION
- DRAWINGS ARE REQUIRED FOR PLAN REVIEW
(minimum size drawings are 18" by 24" 1' = 1/8" scale)

- LIGHTING LOAD FOR COMPLIANCE TO COMCHECK WITH SHELL

- OCCUPANCY LOAD, CLASSIFICATION AND TYPE OF CONSTRUCTION

- ARCHITECT'S STAMP REQUIRED ON EACH SHEET OF ARCHITECTURAL DRAWINGS

- STRUCTURAL ENGINEER'S STAMP REQUIRED ON ALL STRUCTURAL DRAWINGS IF CHANGING SHELL OR STRUCTURAL COMPONENTS

- STRUCTURAL CALCULATIONS IF ABOVE IS REQUIRED

- COMPLETE STRUCTURAL, ELECTRICAL, MECHANICAL & PLUMBING DRAWINGS

- PROVIDE COPY OF BID/CONTRACT BETWEEN OWNER & CONTRACTOR SHOWING CONSTRUCTION VALUATION-- (**PLAN CHECK FEE REQUIRED WITH SUBMITTAL (Call 801-614-9670 for fee amount.)**)

- ARCHITECT'S ESTIMATED MONTHLY WATER CONSUMPTION

- INDICATE IF BUILDING WILL BE SPRINKLED AND IF IT WILL HAVE ALARM SYSTEM

- Davis County Health Dept.** approval is required before the issuance of any permit dealing with food establishments, public swimming pools, day care centers, waste disposal facilities, scavenger salvage operations.

- SUBMIT WATER USAGE REPORT TO **NORTH DAVIS SEWER DISTRICT** AND OBTAIN REQUIRED SEWER IMPACT FEE CALCULATIONS

- CHANGES IN OCCUPANCY TO FOOD SERVICE-CONTACT **NORTH DAVIS SEWER DISTRICT** FOR ADDITIONAL REQUIREMENTS.

- SPECIAL INSPECTION COMPANY INFORMATION AND THEIR CREDENTIALS

- A.D.A. COMPLIANCE REQUIREMENTS.
